



## TETON VILLAGE WINTER 2019-2020 PARKING AGREEMENT and REGULATIONS

This is your parking contract. Please read it carefully. It provides guidelines you must follow.

**Teton Village Parking Passes** are strictly daily use passes and allow the pass holder to park in designated lots without paying the daily parking fees charged to other users. The passes do not allow overnight parking of any kind, parking in spaces designated for hotel guests, fire lanes, short-term parking, emergency zones or other designated no-parking zones. Blocking other parked vehicles or "triple-parking" is prohibited.

**The Ranch Lot Season Pass** allows parking in any space within the designated "Ranch Lot" parking area. **NO ONE IS GUARANTEED A PARKING SPACE WITHIN THE LOT, AND ALL PARKING IS ON A FIRST-COME, FIRST-SERVED BASIS.** This means that if you arrive and the Ranch Lot is full or is deemed unusable for any reason, you will not be allowed to park in the Ranch Lot.

**The All Lot Season Pass** allows parking in any space within any of the designated Teton Village parking areas. These are the Ranch Lot, the Village Lot (Base Village), the Cody Lot (Upper Village) and the Crystal Springs Lot (Mid Village). **NO ONE IS GUARANTEED A PARKING SPACE WITHIN THE DESIGNATED LOTS, AND ALL PARKING IS ON A FIRST-COME, FIRST-SERVED BASIS.** This means that if you arrive and all of the lots are full or are deemed unusable for any reason, you will not be allowed to park in these lots.

**You Park at Your Own Risk.** Individuals park at Teton Village at their own risk. Please lock your vehicle. Teton Village Association Improvement and Service District shall not be liable for any risk, or loss of, or damage to, property of individuals, including vehicles or the contents therein, which may result from the use of parking services or facilities. No bailment is intended or created. Parking in Teton Village parking areas is by season pass or payment of a daily fee only. All passes must be presented to parking attendant(s) and displayed in the front windshield.

**Lost, Stolen or Duplicated Season Passes.** You must report lost or stolen passes promptly. Duplication of season parking passes is strictly prohibited, and duplicated passes will be revoked and confiscated. A **\$30.00 fee** will be charged for **any** pass that must be replaced. **Passes are Non-Transferable.** Season parking passes are issued to the original purchaser only and are valid only for the vehicle(s) listed on this agreement. Passes may be issued with descriptions of two vehicles, but only one of the authorized vehicles may use the pass at any particular time. Passes will be checked upon entry to the parking lots, and no vehicles will be allowed entry to any of the lots without a valid pass in the vehicle or payment of the daily fee. Winter season parking passes are sold on a full winter season basis only. Once parking fees have been charged there will be **no returns, prorated refunds, or cancellations** allowed.

**Winter Season Permit.** Season parking passes are valid for the 2019-2020 Winter season beginning on **November 28, 2019** and ending on **April 12, 2020**.

**Blackout dates apply on the Tier I pass** (Dec. 26-31, 2019; Jan. 18-19, 2020; Feb. 15-16, 2020)

**Availability of Parking is Not Guaranteed.** By signing this Agreement, I acknowledge that the purchase of a Season Parking Pass does not guarantee me a parking space at any time or in any particular place. I hereby waive any and all claims I have or may have against Teton Village Association Improvement Service District arising from or related to my purchase and use of a Season Parking Pass.

**CERTIFICATION.** I certify that I have read the above and understand my responsibility to comply with Teton Village Association Improvement Service District's Regulations. I understand that failure to do so may result in the forfeiture of my parking privileges.
